We opened with the Service Prayer. The 12 Traditions were read by Subcommittee.

<u>Chair:</u> Thank you for allowing me to serve. In the month of May, I visited SEMA to inform them of services provided by the Phoneline. As a result of this, SEMA rescinded their vote to remove themselves from the Phoneline. Diamond Voice has changed the greeting to welcome Western, Central, and Eastern, Mass and RI of NA. *Accepted*.

<u>Secretary</u>: Reported Minutes from April 13, 2013 Regional Phoneline Subcommittee meeting. Secretary thanked the Subcommittee for allowing her to serve and for their support. *Accepted*

Treasurer: Reported May's expenses (\$598.84) as being a little high due to post office expenses that month. Along with June's expenses of \$446.59, these amounts totaled \$1,045.43. Total deposits was \$883.05 with a beginning balance of \$2,597.73 which subtotaled to \$3,480.78 Minus expenses, the ending balance is \$2,435.35. The Treasurer further reported a total of 777 calls for the months of April and May. The Treasurer researched another bank and concluded that our account with Sovereign is actually okay with the Phoneline maintaining a \$1500 balance or 5 transactions per month to avoid Sovereign's fees. The Phoneline usually maintains a \$2,000 to \$3,000 balance. The Treasurer will keep an eye out for Sovereign's \$15 charge. *Accepted*

<u>Literature Contact</u>: Reported 20 calls during the months of April and May: 16 RMD's were mailed out; 5 Professional calls; and 2 Miscellaneous. The Literature Contact further reported a total of 52 calls for the year. *Accepted*

The letters are requesting information on Question 24 on Form PC 2012, and Other incomplete items for 2011. Carrie B. will take care of them at the AG's office and also contact the McFadden CPA for help.

The committee reconciled 1 months' worth of bank statements.

We received budgets from the following committees: Policy, Public Information, Literature, and RMDs and from the RD/RDA.

The annual insurance bills were received and paid. The bill has gone down from \$2,318 to \$2,171.25.

The Finance Committee would like to address to the RSC that the RD/RDA set-aside (budget) has increased from \$1,012 to \$1,478 / region which represents an annual change from \$6,072 to \$8,868. The RD/RDA budget on an annual basis is over \$1,000 greater than the sum of all the other subcommittee budgets combined.
